Cultivation Activities

On the other hand, in the years to come, there will be a big rise in organic agro products and related market. The state of Sikkim has already turned out to be a 100 % organic state. Similarly, other states have also to follow same course of events.

Growers' Group

Additionally, we intend to educate farmers for organic farming on one hand. On the other hand, such farmers never get reasonable market to sell their organically grown products. This gap is the main reason, which restricts farmers from growing organic products.

In order to overcome this we are planning to create growers groups of such farmers. In each group, there shall be minimum of 25 and maximum of 499 farmers. Those farmers would be having approximately 2000 – 3000 acres of land. Such group of farmers will join Mukta Agriculture Limited for the process of organic certification. We will provide seeds, fertilizers and other organic imputs on cost to cost basis and also bear the expenses of organic certification. Moreover technical and agronomical support to entire group of those farmers will also be provided. And at the end, when entire crop is ready, the company shall buyout the entire organically certified production at competitive rates. Such assurance of sale will motivate more and more farmers to join the company and to stay with the company for longer period. At the same time, we are secured with constant supply of organic products.

Such grower group shall have legal standing, since they shall be certified by APEDA nominated agency and thus, it the production derived from such farms will have strong standing in the domestic and international market.
